- 1. As primary obligor and not merely as surety I unconditionally and irrevocably guarantee to NKR Freight Ltd, the due payment and discharge by (the Client) of all of the Client's indebtedness including all monies, debts and liabilities of any nature from time to time due, owing or incurred by the client to NKR Freight Ltd on any current or other account under or in connection with any present or future credit facilities provided by NKR Freight Ltd to the Client (including all credit accrued by the Client prior to the date of this guarantee which remain outstanding).
- 2. I will indemnify NKR Freight Ltd on demand from and against any loss it may incur as a result of or in connection with its contracts with the Client from time to time.
- 3. If the Client defaults in payment of any sums due to NKR Freight Ltd, I, as guarantor, will pay to NKR Freight Ltd on demand an amount equal to the amount unpaid. A certificate by NKR Freight Ltd's officer of the amount so payable shall be conclusive unless manifestly incorrect. NKR Freight Ltd may make demand on me as guarantor without prior demand on the Client.
- 4. My liability will not be discharged by time or any other concessions given to the Client or any third party BY NKR Freight Ltd or by anything NKR Freight may do or omit to do, which (but for this clause) would or may discharge me as guarantor.
- 5. This guarantee shall:
 - a. be in addition to any other guarantee held by the NKR Freight Ltd at any time for the Client's debts;
 - b. be a continuing guarantee and shall not be discharged by any intermediate settlement of the Client's debts to NKR Freight Ltd and shall remain in effect until all sums due from the Client to NKR Freight Ltd have been repaid in full;



- c. remain in force notwithstanding any failure, defect, illegality of or in any of the Client's obligations in respect of its debts to NKR Freight Ltd; and
- d. ensure to the benefit of the Client and its assigns.
